American Association of Orthodontists "Host a New Doctor Program" Sweepstakes

Official Rules
Dates: November 10, 2025 - December 8, 2025

NO PURCHASE IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

- **1. SPONSOR, ADMINISTRATOR:** The American Association of Orthodontists ("AAO" or "Sponsor") shall serve as the sponsor and administrator of the American Association of Orthodontists "Host a New Doctor Program" Sweepstakes ("Sweepstakes").
- **2. ELIGIBILITY:** This Sweepstakes is open only to legal residents of the 50 United States and the District of Columbia, or Canada (excluding Puerto Rico and all United States territories and possessions), who are active members of the AAO, graduated no earlier than 2021, have been in practice between 0-5 years, and have at least \$500,000 of student debt at the time of entry. You need not be present to win. Employees (and their immediate families or those living in the same household) of Sponsor and its respective affiliates, subsidiaries, divisions, parent and related companies, suppliers, printers and advertising, promotional and judging agencies are not eligible to enter or win. Individuals who appear on the U.S. Government Department of Treasury's Specially Designated Nationals List are also not eligible to enter or win. An "Entrant" is an eligible person who submits an entry in accordance with these Official Rules.
- **3. SWEEPSTAKES PERIOD:** The Sweepstakes begins November 10, 2025, 12:01 a.m., C.T., and ends December 8, 2025, 11:59 p.m., C.T. (the "Sweepstakes Period").
- **4. HOW TO ENTER:** You may enter this Sweepstakes only via the entry methods described below (each, an "Entry"). All entries must be received by 11:59 p.m., C.T. of the last day of the Sweepstakes Period (December 8, 2025), regardless of the method of entry. Proof of depositing entry in mail is not considered proof of delivery or receipt. No photocopied or mechanically reproduced entries will be accepted. Illegible, incomplete and duplicate entries will be disqualified. Entries will not be accepted from post office boxes. All entries become the property of Sponsor and will not be returned.
 - a. <u>WEB FORM ENTRY METHOD:</u> Beginning at the beginning of the Sweepstakes Period, you may enter this Sweepstakes by completing all information on the AAO "Host a New Doctor Program" entry form at https://www2.aaoinfo.org/aao-annual-session-host-a-new-doctor-program-application/.
 - b. <u>MAIL-IN ENTRY METHOD:</u> Alternatively, you may enter the Sweepstakes by hand-printing the words American Association of Orthodontists "Host a New Doctor Program" Sweepstakes, your name, age, address, city, state, zip code, telephone number, and e-mail address (if applicable) on a 3" x 5" card and mailing it in an envelope to: American Association of Orthodontists "Host a New Doctor Program" Sweepstakes, American Association or Orthodontists, 401 North Lindbergh Boulevard, St. Louis, MO 63141-7816. All mail-in entries must be

received by the Sponsor by 11:59 p.m., C.T. of the last day of the Sweepstakes Period.

By submitting an Entry, each Entrant certifies that the Entrant has the necessary authorization to use the content contained therein. If another entity or person owns the rights to all or part of the Entry, the Entrant must have obtained written consent/permission from the owner or an authorized representative of the owner. Each Entrant who submits an Entry acknowledges that, by submitting the Entry, such Entrant will be held fully liable under the law for any copyright or other intellectual property violations.

By submitting the Entry, each Entrant certifies that the Entrant has the necessary authorization from the person(s) in the Entry to submit the Entry in the Sweepstakes. In addition, the Entry may not contain any visible brand names, logos, trademarks or other intellectual property owned by any company other than the Sponsor.

Entries must not (a) contain any false, inaccurate or misleading material, (b) violate any law or regulation, (c) be libelous, inflammatory, threatening or harassing, (d) instigate others to commit illegal activities, (e) contain any obscene, offensive or illicit content, or (f) describe or show any dangerous or illegal activity or behavior, (g) contain any viruses, worms, or other computer programming intended to or that could interfere with the ability of others to enjoy the Sweepstakes, or (h) violate any policies or terms of the platform that is used to submit an Entry.

In the event of a dispute regarding the identity of the person submitting an Entry, the entry will be deemed submitted by the authorized account holder of the account at the time of entry. "Authorized account holder" is defined as the natural person who is assigned an account by Instagram, Facebook, Twitter, or any other platform used to submit an Entry as applicable. Potential winners may be required to show proof of being the authorized account holder.

If it is discovered that an Entrant has registered or attempted to register more than once using multiple e-mail addresses, social media accounts, telephone numbers, multiple identities, IP addresses, use of proxy servers or any other method of unauthorized entry, all in Sponsor's sole and absolute discretion, all of that Entrant's entries will be declared null and void, Entrant will be disqualified from the Sweepstakes and any Prize that Entrant might have been entitled to receive will not be awarded to him/her. - **5. PRIZES AND APPROXIMATE RETAIL VALUE:** There will be five (5) hosted recipients awarded. Each prize will be awarded to a randomly drawn winner of the Sweepstakes. The prizes will be assigned to the winners in the order in which the winners are drawn from the pool of all applicable entries.
 - The **prize** consists solely of the following: complimentary conference registration for Annual Session, complimentary three (3) night hotel stay, travel stipend of \$500 to be

reimbursed following the Annual Session (this piece is dependent upon verification that program requirements have been met).

Approximate retail value ("ARV") for the Prize is \$3,000.00.

- **RANDOM DRAWING:** Winner of the Prize ("Winner") will be selected in a random drawing from among all eligible entries, on or about December 8, 2025 ("Drawing Date") by the Sponsor, whose decisions are final and binding in all matters relating to this Sweepstakes. Sponsor will use reasonable efforts to contact Winner within two (2) weeks of the Drawing Date. Sponsor shall not be required to use extraordinary or unreasonable efforts to locate or contact a potential winner or award the Prize. If the potential winner of the Prize cannot be found or does not respond to the applicable prize notice, Sponsor may (in its sole discretion) select another potential winner of the Prize in a random drawing from among all eligible entries.
- **ODDS OF WINNING:** Odds of winning a Prize depend on the total number of eligible entries received for the Sweepstakes and are equal regardless of method of entry.

8. PRIZE CONDITIONS:

- **GENERAL CONDITIONS.** No substitution for any Prize will be permitted. If a. necessary due to the unavailability of the Prize, a prize of equal or greater value will be awarded at the discretion of the Sponsor. Sponsor shall not be required to use extraordinary or unreasonable efforts to locate or contact a potential winner or award the Prize. If the potential winner of the Prize cannot be found or does not respond to the applicable prize notice, Sponsor may (in its sole discretion) select another potential winner of the Prize in a random drawing from among all eligible entries. Prize is not transferable, assignable or redeemable for cash. Winner may be required to execute and return an Affidavit of Eligibility, Publicity/Liability Release, and an IRS W-9 form (i.e. Request for Taxpayer Identification Number and Certification) within fifteen (15) days of issuance by Sponsor. Failure to return all required documents in this time period may result in the Winner being disqualified and an alternate Winner selected. If a prize notification is returned to Sponsor as undeliverable or if an Entrant is found to be ineligible or declines to accept a Prize for any reason, an alternate Winner will be selected. Sponsor reserves the right to modify, suspend or terminate the Sweepstakes in the event that it becomes necessary due to circumstances beyond Sponsor's control. In the event the Sweepstakes is terminated early, Winner will be selected from all eligible entries received at the time of termination.
